# PRIMA INDUSTRIE S.P.A. BOARD OF DIRECTORS CALLS THE EXTRAORDINARY SHAREHOLDERS' MEETING TO ASK FOR THE POWERS TO CARRY OUT, ALSO IN SEVERAL TRANCHES AND WITH MODALITIES TO BE DEFINED,

## A SHARE CAPITAL INCREASE FOR A TOTAL MAXIMUM AMOUNT OF 50 MILLION EUROS (INCLUDING SHARE PREMIUM)

Collegno (TO), 29 April 2009 – The Board of Directors of PRIMA INDUSTRIE S.p.A., a leader in high technology laser systems for industrial applications and sheet metal working systems, resolved to call the Extraordinary Shareholders' Meeting.

The Board, in fact, intends to propose to the Shareholders' Meeting the grant of powers to increase the company share capital, pursuant to articles 2441 e 2443 civil code, through the issuing of ordinary shares and/or warrants, as well as powers to issue convertible bonds and/or with warrants according to article 2420 ter c.c., to be offered in option to those having the right.

The Board of Directors also proposes to ask for the powers to increase the company share capital up to a maximum of 10% of the existing share capital according to art. 2443 c.c., with the exclusion of the option right according to art. 2441, fourth paragraph second sentence c.c. and pursuant to art. 8, second paragraph, second sentence of the company by-laws.

In any case the capital increase resulting from the use of the above mentioned powers will not exceed the total amount of Euro 50,000,000.00 (including possible share premium)

The Extraordinary Shareholders' Meeting has been called on June 5 (1<sup>st</sup> call), June 8 (2<sup>nd</sup> call) and, if needed, on June 9 (3<sup>rd</sup> call).

In order to attend the Shareholders' Meeting will have to show the relevant certification released by their financial institutions at least two days before the day of the Shareholders' Meeting on first call, according to article 12 of the company by-laws.

The Group has a wide range of machines for the cutting and bending of sheet metal: Punching machines, Combined punching/shearing systems, Combined punching/laser cutting systems, Panel Benders and automation systems.

<u>Industrial Electronics</u>: it includes development and design of power and control electronics, with relevant software. Furthermore the Group designs and produces internally the Numeric Controls to be installed on its own Laser Machines

A little over 30 year years since its establishment the Group can count on thousands of machines installed in more than 60 countries worldwide, is present with property commercial and assistance units in over 15 countries and it is among the main worldwide constructors in its own reference market.
