Obtainment of golden power authorization in Italy

24 October 2022 – It is announced that, by note No. DICAGP-0004544 submitted today, the Italian Presidency of the Council of Ministers has informed Femto Technologies S.p.A. and Prima Industrie S.p.A. of its decision not to exercise the special powers over corporate structures and activities of strategic importance pursuant to Law Decree No. 21/2012 (s.c. golden power regulation).

It is reminded that the obtainment of such authorization by the competent Italian authority is one of the foreign direct investment authorizations required by law to the competent European authorities.

For sake of clarity, until the other foreign direct investment authorizations are not obtained, the relevant Conditions Precedent cannot be considered as fulfilled.
