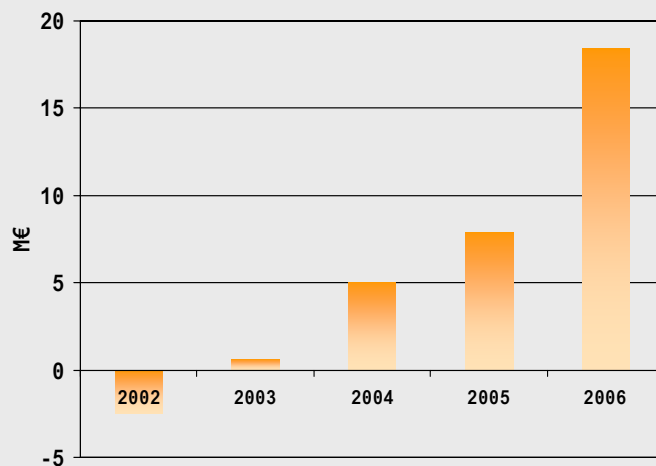

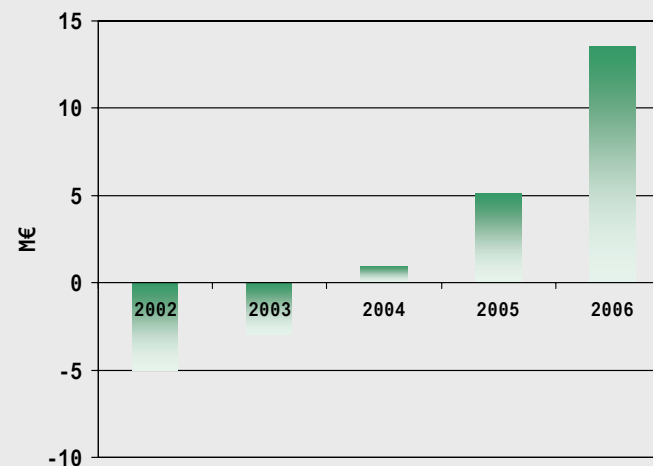
CONSOLIDATED EBITDA

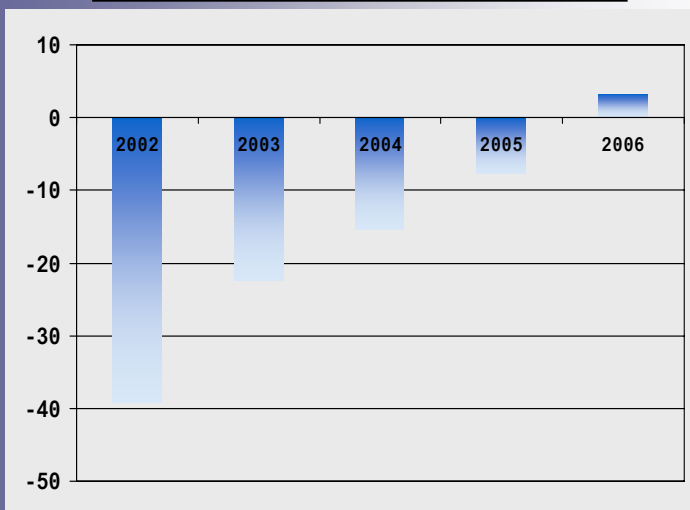

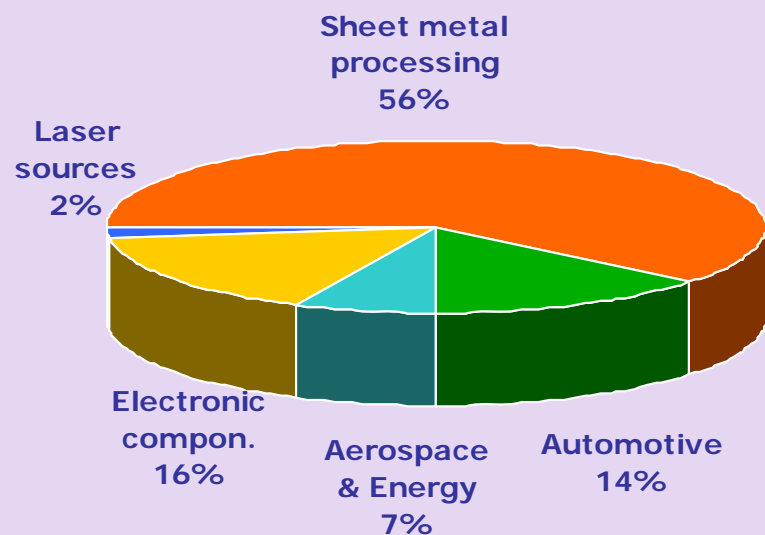
ORDER ACQUISITION TREND



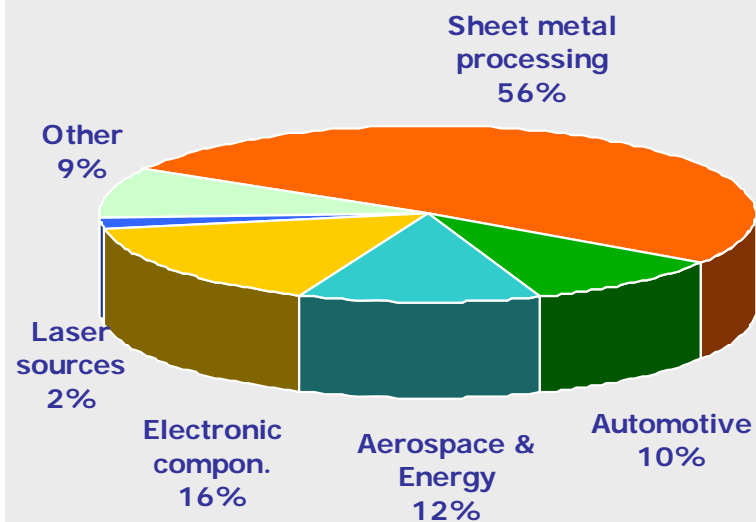


SALES BREAKDOWN BY MARKET

June 30, 2007



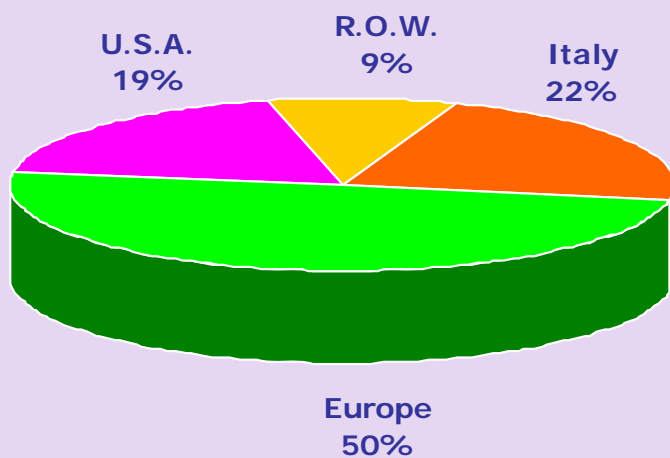

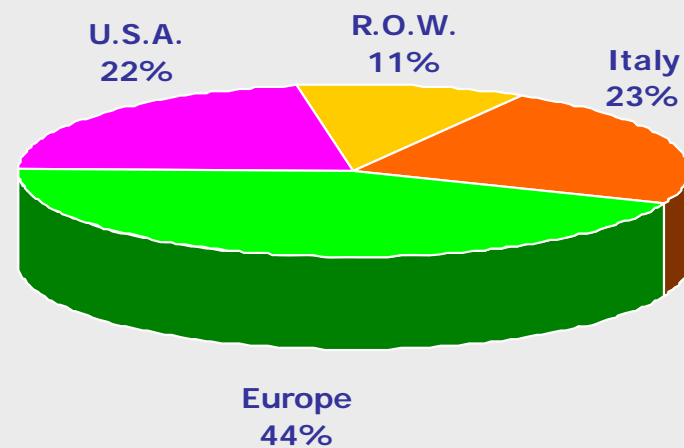


SALES BREAKDOWN BY GEOGRAPHIC AREA

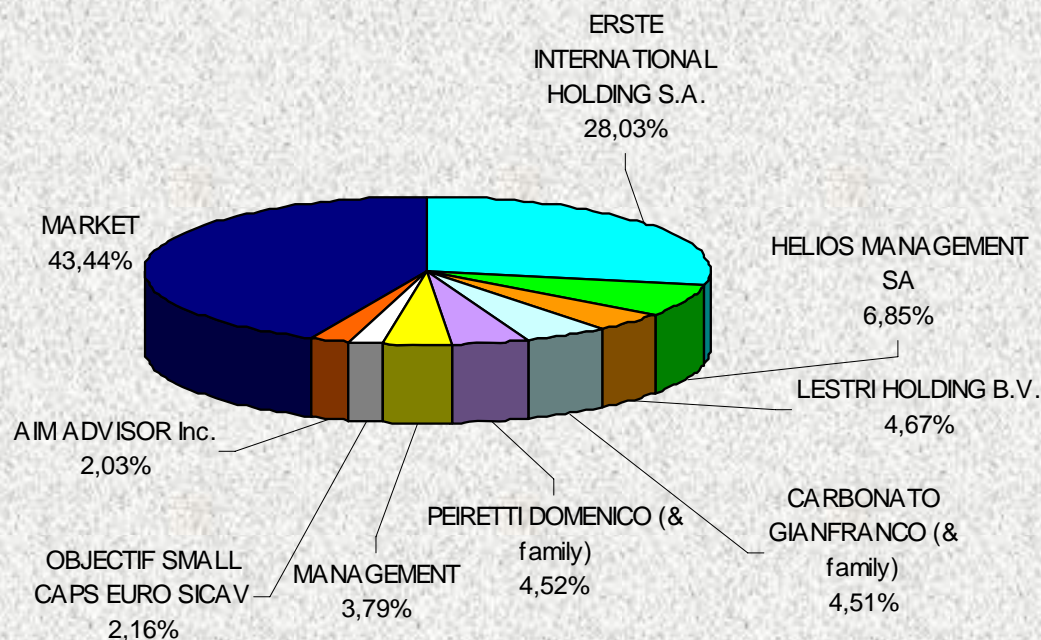


PRIMA INDUSTRIE VS ALLSTAR INDEX
